- Legislative Duane Roberson

 - Legislative Session ends in three weeks
 - 25-1278 Restructuring SPF
 - Contemplating an addition
 - o WBL
 - Concurrent Enrollment (including AP and IB with passing)
 - Certifications
 - Shifts CDIP
 - Line item for certifications exists

- Moves SAT/ACT out of PWR
- Grad/dropout rates remain
- Big Blur- no number
 - Reorganizes funding from ASCENT/CDIP/TREP/PTEC/etc.
 - New bucket of \$10,000 to schools without a PWR metric for incentivizing within 3 years - not competitive - will convert to an innovative grant in three years
 - CDIP is converting into separate buckets
 - Concurrent Enrollment (AP, IB tests) \$2.8 M
 - Certifications CDIP list -\$6M
 - WBL \$4.6 M
 - ASCENT will continue for one more year
 - Reduction of PPR to approx. \$7,000.00
 - Will sunset after 2025-2026 school year
 - \$7,000.00 will then be redistributed into CDIP buckets (above).
 - TREP TBD...seems to be expanded
- Program of Work Nick Williams
 - The 2025-2026 CACTA Program of Work (POW) continues to need revision. I revised the POW document to align 100% with CACTE; however, I have learned that CACTA only needs to align with CACTE by including at least one common strategy. As a result, we will continue to keep the same strategies outlined in our current POW to develop and perform within our current and ongoing improvement strategies.
 - Recommendation to change IAED to "CTE for All"
 - Work remains the same, naming convention recommended to change.
 - Need to change in all places
 - The work continues

• CCCS Liaison – Victoria Crownover

- o This has been a busy legislative season, especially for K-12 with anticipated bills/changes related to the Accountability system (specifically a new PWR indicator) and PWR funding structures. Depending on the changes, CCCS will work with CDE and districts on how those changes relate to or impact CTE, including data reporting. Federally, at the current time, no expected changes to Perkins for next year and the state is awaiting our award estimate.
- o May 8 will be a Career Clusters convening in Colorado to discuss what implementation of the new national modernized career clusters could look like and a proposed draft of that is expected at CACTE this summer.
- o CTE staff are working with the statewide longitudinal data project to partner on ways to include CTE data in that project. CLNA, or the regional needs assessments will be due this year and CCCS is planning a fall roadshow to 5 locations around the state to help facilitate these conversations (tentatively in September). Program approvals are being

processed in preparation for the end of the fiscal year, grants are wrapping up, and training on CTA and Perkins is occurring this month. Student CTSO conferences have been providing amazing opportunities for learners to demonstrate their skills since February continuing until June, and the team is planning professional development activities for the fall. Please share any needs or suggestions related to training or anything else and we look forward to continuing to partner!
